Notes

In some instances Members haven't yet made or will not make claims for all or part of the year. Members duties at times necessitate the use of Train travel and overnight accomodation. Most of these costs are met direct by the Authority and not included in the above figures.
2. Basic and Special Responsibility allowances are annual figures.
3. Cllr DJ Wilcox has carried out duties for other outside organisations from whom we have reclaimed the appropriate costs (£3,660) therefore reducing the cost to the Authority .
