Most of these costs are met direct by the Authority and not included in the above figures.
2. Basic and Special Responsibility allowances are annual figures.
3. Cllr DJ Wilcox has carried out duties for other outside organisations from whom we have reclaimed the appropriate costs £1,260.66 therefore reducing the cost to the Authority . However,as the payments were initially made by the Council they are included in the total above The net cost to the Authority of Cllr D Wilcox travel and subsistence was £2,951.08
