

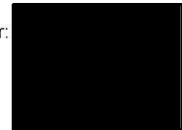
# DCC Members Allowances

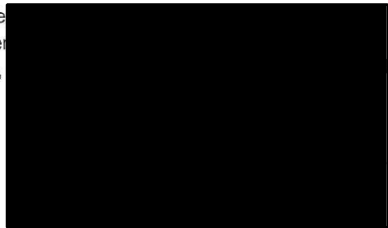
