### Notes

1. Basic and Special Responsibility allowances are annual figures.  
The Basic and Special Responsibility Allowances were increased by 1% from 1 April 2013, 2.2% from 1 January 2015 and 1% from 1 April 2016 however some Members renounced these increases.
2. Travel amounts are the totals paid during the year based on claims made by Members.  
In some instances Members haven't yet made or will not make claims for all or part of the year.  
Members duties at times necessitate the use of Train travel and overnight accommodation.  
Most of these costs are met direct by the Authority and not included in the above figures.
3. The Special Responsibility Allowance for Chair and Vice Chair of Pensions and Investment Committee was funded by Derbyshire Pension Fund.
