EPS Pages 12 and 128 refer to “25% of items were prescribed using the Electronic Prescription Service”. Yet page 126 talks of all four CCGs exceeding the GMS contract target of 56% of all prescriptions being issued by EPS. Please ensure that there is clarity over how these percentages are calculated. HLP Page 129 refers to 188 HLP Champions being trained “to date”. It would be helpful to specify which date that was as it is expected that the number may well be significantly higher by the time the final PNA will be published as the final Quality Payment review date was 24th November. Number of pharmacies Amber Valley has (according to page 28) 26 pharmacies. Yet the table on page 29 indicates 27 pharmacies offer MURs. Can these figures be confirmed prior to final publication? Reference citations There is some inconsistency in the presentation of reference citations particularly in pages 119-124 which would benefit from clarifying; whilst many are referenced by superscript and footnote, some are not - for example page 123 under Smoking Cessation (Brown, et al., 2016).
