

Major Schemes Improvements to Rights of Way Stoney Middleton Byway Open to All Traffic 15

On 12 July 2016 the Derbyshire County Council Cabinet Member – Highways, Traffic and Infrastructure approved a report for an initial public consultation on the possible implementation of a Traffic Regulation Order (TRO) on Stoney Middleton Byway Open to All Traffic 15 (Jacobs Ladder) to prevent or restrict use by motorised vehicles.
