APPOINTMENT OF SCHOOL GOVERNORS

1. Purpose of report

To ask the Cabinet member to agree the appointment/nomination of persons to serve as Authority/Local Authority school governors.

2. Information and Analysis

Appointments/nominations to school governing bodies are proposed as set out below.

For schools constituted under the School Governance (Constitution) (England) Regulations 2007, the Local Authority **appoints** Authority Governors. The Cabinet member is asked to approve the appointment of persons to serve on the governing bodies of these schools.

For schools constituted under the School Governance (Constitution) (England) Regulations 2012, the Local Authority **nominates** Local Authority Governors and schools appoint. The Cabinet member is asked to approve the nomination of persons to serve on the governing bodies of these schools.

The appointments will be subject to the completion of a Declaration of Eligibility form and a proof of identity check.
