APPOINTMENT OF SCHOOL GOVERNORS

1. Purpose of report

To ask the Cabinet member to agree the appointment of persons to serve as Authority school governors.

2. Information and Analysis

Appointments to school Governing Bodies are proposed as set out below.

A delay in the reappointments which would occur if submitted via Local Area Committees would result in a lapse in their period of governance which is a significant factor should the governing body decide to reconstitute under the 2012 Constitution Regulations, as 'seniority' is the current criterion for deciding continuing governorship in each category.

A delay in the new appointment which would occur if submitted via Local Area Committee would be detrimental to school improvement. The new appointment has been identified by the Senior Advisor for the school as being able to significantly contribute to school improvement at this time.

The appointments will be subject to the completion of a Declaration of Eligibility form and a proof of identity check.

3. Other considerations

In preparing this report the relevance of the following factors has been considered:- prevention of crime and disorder, equality of opportunity and health, legal, financial, personnel and property considerations.
