To ask the Cabinet member to agree the appointment of persons to serve as Authority school governors and the nomination of persons to serve as Local Authority school governors.

2. Information and Analysis

Appointments and nominations to school Governing Bodies are proposed as set out below.

The dates for the Local Area Committees where the following nominations would normally be considered are scheduled for the latter part of September. Earlier approval would enable these candidates to contribute to the work of their governing bodies at this important time at the start of the academic year.

For schools constituted under the School Governance (Constitution) (England) Regulations 2007, the Local Authority **appoints** Authority Governors. The Cabinet member is asked to approve the appointment of persons to serve on the Governing Bodies of these schools.

For schools constituted under the School Governance (Constitution) (England) Regulations 2012, the Local Authority **nominates** Local Authority Governors and schools appoint. The Cabinet member is asked to approve the nomination of persons to serve on the governing bodies of these schools

The appointments will be subject to the completion of a Declaration of Eligibility form and a proof of identity check.
