WORK PROGRAMME 2015/16

1. Purpose of the Report

To consider the Improvement and Scrutiny Committee - People work programme for 2015/16.

2. Information

The Committee is undertaking a review of the change to adult social care eligibility thresholds. The working group has engaged with a wide range of stakeholders to ascertain the extent of any impacts following the changes. A final review report will be considered by the Committee at this meeting.

The safeguarding working group continue to meet monthly. A final report on findings from a visit and receiving evidence on Starting Point will be considered by the Committee at this meeting. The working group also recently conducted a frontline visit programme. This included speaking to Multi-Agency Teams at Godkin House, Police staff at the Central Referral Unit and Children Centre staff.

The working group held consultation with Members of the Youth Council at their conference in May 2015. Feedback was gained on the awareness and services delivered by the authority around issues of child sexual exploitation (CSE), particularly on-line safety. The consultation feedback will be used in the review of CSE. The Committee will have also agreed to a review of how the authority is deterring radicalisation in schools.
