**WORK PROGRAMME 2015/16**

**1. Purpose of the Report**

To consider the Improvement and Scrutiny Committee - People work programme for 2015/16.

**2. Information**

The Committee is currently undertaking two scrutiny reviews – radicalisation in schools and child sexual exploitation. The former is being brought before this Committee today for approval of the final review report. The latter is in progress and working group members have taken evidence from senior officers and organisations against different lines of inquiry. A full consultation with young people, parents/carers and external organisations is being progressed.

The Committee has undertaken to include in its work programme a review of Hate Crime. The review has already been agreed at the Places Committee in May 2015. An initial briefing session has been delivered to Members by senior officers. The scope of the review is being presented to this committee today for agreement.
