WORK PROGRAMME 2015/16

1. Purpose of the Report

To consider the Improvement and Scrutiny Committee - People work programme for 2015/16.

2. Information

The Committee is currently undertaking two scrutiny reviews – radicalisation in schools and child sexual exploitation. Both are in the early stages of the review process. Working group members have held initial briefing sessions with senior officers and have agreed lines of inquiry to pursue.

Cabinet received the scrutiny review into adult social care eligibility threshold changes and approved all recommendations in July 2015. An action plan for implementing the recommendations has been produced by the Adult Care Department and will be presented to the Committee in September 2015, in accordance with the Scrutiny protocol.

The Safeguarding Working Group continues to meet monthly and is currently focusing on the child sexual exploitation review. Cabinet received the scrutiny report on Starting Point and approved all recommendations in July 2015. An action plan for implementing the recommendations has been produced and will be presented to the Committee in September 2015, in accordance with the Scrutiny Protocol.
