WORK PROGRAMME 2018/19

1. Purpose of the Report

To identify and agree items to be included in the 2018/19 work programme for the Improvement and Scrutiny Committee - People.

A proposed work programme for 2018/19 is given at Appendix one. As issues emerge during the course of the year they can, with the Chairman's agreement, be added to the work programme.
