The project sponsors are required to submit a full stage 2 business case to the IIB by March 2018. This project will remain at high risk until this is delivered.

Drakelow Park- The promoter has been given until the January IIB to finalise the loan arrangement with Derbyshire County Council and to become fully compliant with Stage 2 of the Local Assurance Framework.
