

NOTICE OF MAKING OF AN ORDER

HIGHWAYS ACT 1980

THE DERBYSHIRE COUNTY COUNCIL (PUBLIC FOOTPATH NO.9 (PART) – PARISH OF HARTSHORNE) PUBLIC PATH DIVERSION ORDER 2019

The above order, made on 8th August 2019 under Section 119 of the Highways Act 1980, if confirmed without modifications, will divert the whole width of that part of Public Footpath No. 9 in the Parish of Hartshorne commencing at Point A (Ordnance Survey Grid Reference ("GR") SK 3275 2097) and proceeding in a generally south easterly direction to Point B (GR SK 3284 2085), a total distance of 143 metres or thereabouts to a stone and natural surfaced footpath at Church Street in the Parish of Hartshorne, commencing from Point C (GR SK 3276 2097) and proceeding in a generally south easterly direction to Point D (GR SK 3280 2093), continuing in a generally south easterly direction to Point E (GR SK 3284 2086) and finally in a generally south south westerly direction to the aforementioned Point B (GR SK 3284 2085), a total distance of 149 metres or thereabouts, with a width of 2 metres except where it is shown shaded grey on the order map, where the width varies between 1.3 and 1.8 metres.

A copy of the order and the order map may be seen free of charge at the offices of the Derbyshire County Council, County Hall, Matlock from 9.00 am to 5.00 pm Monday to Friday and also at Woodville Post Office, 67 High Street, Swadlincote, Derbyshire, DE11 7EA from 8.30 am to 5.30 pm Monday to Friday and 9.00 am to 12.30 pm Saturdays. Copies of the order and map may be bought from the Derbyshire County Council at the price of £1.00.

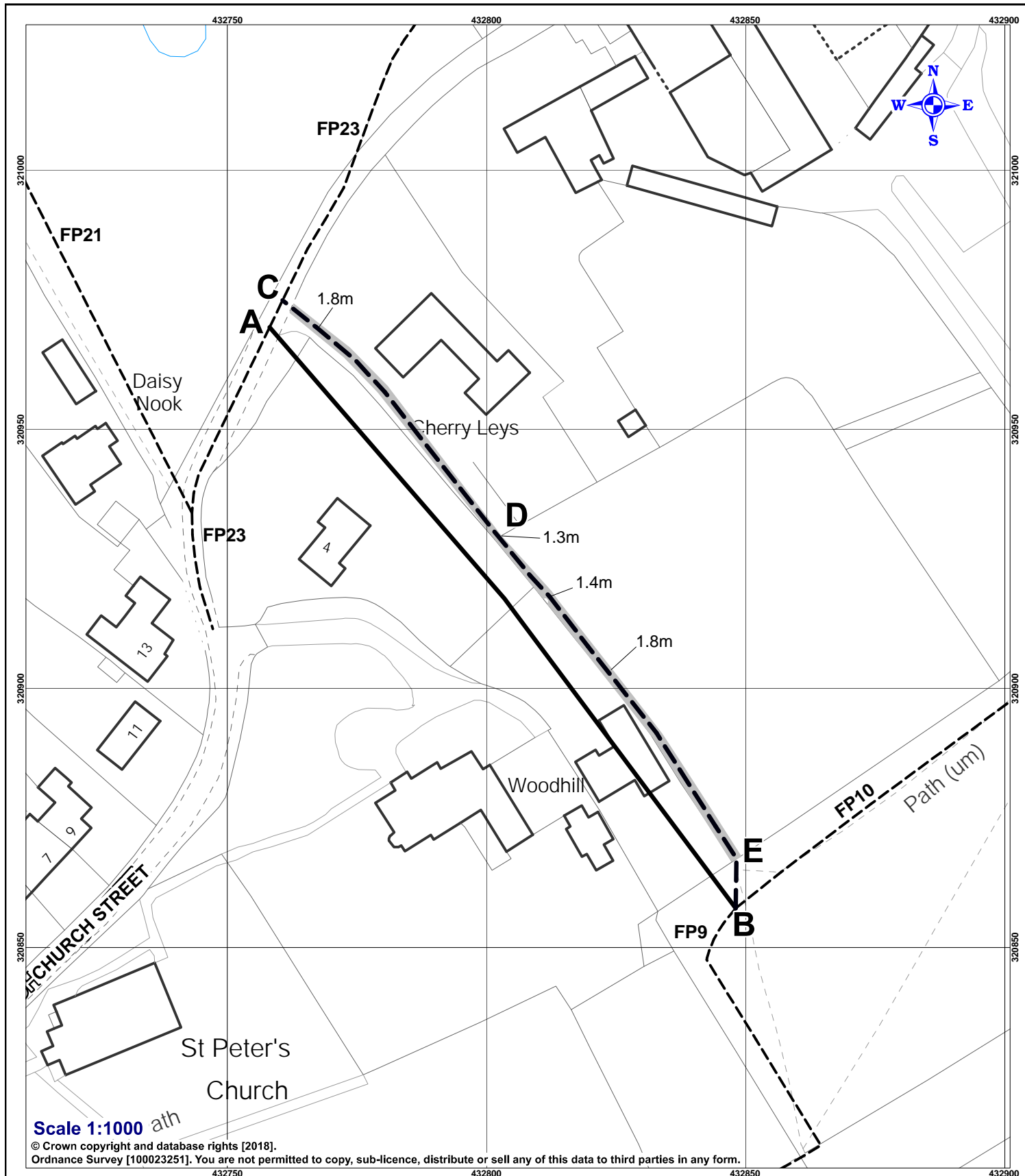
