How to complete this ID Sheet document

When you apply or renew your Derbyshire Chaperone Licence, we are required to complete an Enhanced Disclosure and Barring Service (DBS) check to ensure that you are not barred from working with children.

You must provide **3 forms of ID documents** in order for us to verify your identity to proceed with a DBS check. You must provide at least: **ONE document from Group 1 and a further TWO documents from either Group 1, 2a or 2b**. We must see the original ID documents in person.

We have created this sheet for you to fill in with any information we will require from your ID documents to help us minimise the amount of time it takes us to verify each person and also means that we don't require to handle photocopies of your ID documents. Ideally, you will **enter the information electronically** however we can accept forms that have been handwritten if the information is readable.

Please input your:

- Full legal name as it appears on your ID documents. Example: John Adam Smith
- Current Home Address including postcode (one of your ID documents must have your address on it)
- Date of Birth
- Answer (Yes / No) for if you have ever changed your name.
