ADMISSION POLICY FOR SEPTEMBER 2018

ADMISSIONS POLICY OF FRIESLAND SCHOOL, NOTTINGHAM

Boys and girls will be admitted at age 11 years without reference to ability or aptitude. The number of intended admissions for the year commencing September 2018 will be 225.

The school will initially consider all applications and where applications for admission exceed the number of places available, the following criteria will be applied, in the order set out below, to decide which children to admit:

Children with statements of Special Educational Need or have an Education, Health and Care (EHC) plan names the School must be admitted.

CATEGORY 1

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order.

CATEGORY 2

Children living in the normal area served by the School. A map of this area is available to view. Documentary evidence of permanent residence at the property may be required.

CATEGORY 3

Where the child has a brother or sister attending the school at the time of admission.

The term brother or sister includes:

- (a) a half-brother and/or a half-sister
- (b) a legally adopted child being regarded as a brother or sister
- (c) a step-brother and/or step-sister residing in the same family unit

CATEGORY 4

Where there are medical grounds (supported by a Doctor's Certificate) for admitting the child. The medical grounds must make a case that it is imperative that the child in question attends Friesland School rather than any other secondary school.

CATEGORY 5

Other children who live outside the normal area served by the school.

In the event of over-subscription within any of the above categories, applications will be placed in order using distance from the school, with those living nearer to the school being accorded the higher priority. Distance will be measured by the local authority using the Children and Younger Adults Department's Geographical Information System (GIS) which measures the distance from home to school in a straight line and is calculated to within 2 metres. The measurement is taken from the postal address file, normally the house front door to the nearest gate or entrance to the school.
