Summary

The site is a green field site that is used as arable land, which is located on Acresford Road, Acresford. The site has potential access onto Acresford Road. The site slopes up from Acresford Road. It has been proposed through the SHLAA submission that approximately 135 dwellings could be provided on this site. There is no developer interest on the site.

The site is considered to be potentially suitable as the site is located within an area protected by countryside policy. This site would be served by sewerage works that discharge to the River Mease Special Area of Conservation. This river is failing its water quality objectives and this has the potential to be a significant constraint to residential development.

The site is considered available as the existing use would not need to be relocated and the site is in one ownership.

The site is considered achievable as it is a green field site and there is a reasonable prospect that the site will be financially viable for residential development in the future.
