Physical constraints (i.e. topography):


The site has been assessed and it is considered that the site is physically constrained by: - the topography of the site.

Summary

The site is a green field site that is currently part of a garden that is located to the west of Findern on the opposite side of the A38. The site has potential access onto Little Derby Hill. We have estimated a site capacity of 33 dwellings. There is no developer interest on the site.

The site is considered to be potentially suitable as it is currently restricted by local planning policy as the site is in an area protected by countryside policy.

The site is considered available as the majority of the existing use would not need to be relocated and the site is in one ownership.

The site is considered achievable as it is a green field site and there is a reasonable prospect that the site will be financially viable for residential development in the future. However, the impact on viability of the gradient on the site would require further assessment.
