Summary

The site is a green field site that is currently used as agricultural land. The site is located to the west of Aston on Trent. The site has potential access onto Chellaston Lane though this would require demolition of a residential dwelling. We have estimated a site capacity of 35 dwellings. There is medium developer interest on the site.

The site is considered to be potentially suitable as it is currently restricted by local planning policy as the site is in an area protected by countryside policy.

The site is considered available as the existing use would not need to be relocated and the site is in one ownership.

The site is considered achievable as it is a green field site and there is a reasonable prospect that the site will be financially viable for residential development in the future. However, further assessment would be required on the demolition of the residential dwelling for access and its impact on viability.
