**Summary**

The site is a green field site that is currently used as agricultural land. The site is located to the east of Mount Pleasant. The site has potential access onto Mount Pleasant Road. We have estimated a site capacity of 25 dwellings. There is no developer interest on the site.

The site is considered to be potentially suitable as it is currently restricted by local planning policy as the site is in an area protected by countryside policy. Further assessment would be required on the Tree Preservation Orders.

The site is considered available as the existing use would not need to be relocated and the site is in one ownership.

The site is considered achievable as it is a green field site and there is a reasonable prospect that the site will be financially viable for residential development in the future.
