
The site has been assessed and it is considered that the site is not physically constrained.

#### Summary

The site is a green field site that is currently used as agricultural land that is located to the north of Winshill, Burton on Trent. The site has potential access onto Hawfield Lane. We have estimated a site capacity of 594 dwellings. There is high developer interest on the site.

The site is considered to be potentially suitable as it is currently restricted by local planning policy as the site is in an area protected by countryside policy.

The site is considered available as the existing use would not need to be relocated and the site is in one ownership.
