(KINDER ROAD AND EDALE ROAD, HAYFIELD TO BARBER BOOTH, EDALE)  
(PROHIBITION OF DRIVING) ORDER 1979

The Derbyshire County Council in exercise of their powers under Section 1 (1), (2) and (3) and 84D of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 and of all other powers them enabling in that behalf and after consultation with the chief officer of police in accordance with Section 84C (1) of the said Act of 1967 hereby make the following Order:-

1. Subject to Clause 2 no person shall cause any vehicle to proceed in the length of road detailed in the Schedule to this Order
2. This Order shall not operate so as to prevent persons from gaining access to premises adjoining the length of road
3. This Order shall come into operation on the ninth day of July One thousand nine hundred and seventy nine and may be cited as "The Derbyshire County Council (Kinder Road and Edale Road, Hayfield to Barber Booth, Edale) (Prohibition of Driving) Order 1979
4. The Derbyshire County Council (Barber Booth to Upper Booth Road, Edale) (Prohibition of Driving) Order 1976 and the Derbyshire County Council (Kinder Road and Edale Road, Hayfield) (Prohibition of Driving) Order 1973 are hereby revoked

SCHEDULE

Length of road between Hayfield and Barber Booth

Kinder Road, Hayfield	-	From its junction with the Edale Road at Bowden Bridge in a Northerly direction to its junction with Booth Bridge continuing as
Edale Road, Hayfield and the continuous length of the Hayfield to Barber Booth Road within the Parish of Edale	-	From its junction with Kinder Road at Bowden Bridge in a south easterly direction to a point 680 metres (736 yards) west of its junction with the Barber Booth to Rushop Edge Road at Barber Booth
