## Dealing with Bereavement

### There are said to be 5 stages of grief:

- Denial – Shock, numbness, cannot believe it, feels unreal, empty. Can't cope with routine tasks
- Guilt – I should've done..., I wish I had not done..., Irritable, critical of previous actions
- Anger – Why has this happened to me? It's not fair. Feel hurt, unhappy and restless
- Sadness – You will likely feel low and/or depressed. Fear that you are losing control. Feel despair that nothing will be the same. May lose sense of identity and self-worth.
- Acceptance – It can take at least 2 years to make the adjustment in some cases can be longer. Life will not be the same, things will be different but that doesn't mean there can't be 'good' days. However, you will likely still have down days.

These are all normal stages of grief. It's okay to feel this way and it can help to talk to family and friends.
